BENEFICIARY CONCEPT AND DESCRIPTION

The 12TH ANNUAL SWAMP FOX CHILI COOK OFF *is a county-wide fundraising opportunity.* This is a one-of-a-kind benefit.

Beneficiaries are defined as: Any non profit or not-for-profit organized group in Marion County who is willing to participate in this year's event and needing funds for their organization. To qualify as a **participating beneficiary**, the organization must agree to sell tickets with two firm stipulations.

Applications must be submitted and approved by **February 4, 2022.**

Each qualified group's earning potential is only limited by their sales ability. Qualifying organizations will be given Chili Cook Off tickets to sell for **\$10.00 each**. Tickets are distributed in **blocks of 20**. Qualifying organizations may request up to 5 blocks. (Each group may want to start with one or two blocks and request more as needed).

Each group will be allowed to keep 50% of their total ticket sales.

All tickets sold by organizations must be completed **by Wednesday, March 2nd, 2022.** All money and unsold tickets must be submitted to the HMRA office by noon, Friday, March 4th, 2022.

There are two firm stipulations that a qualifying organization must agree to in order to be a beneficiary participant.

TWO FIRM STIPULATIONS:

1. The Swamp Fox Chili Cook Off organizers **REQUIRE** a minimum of 2 volunteers to help with the event, either on a committee, or as a helper at the event, for a minimum of 1 hour. Event hours for volunteers will begin at 9:00 am and end around 5:00 pm. We will have a Volunteer Coordinator that volunteers will report to.
2. All unsold tickets **MUST** be returned to HMRA by noon on Friday, March 4th, 2022.

Any organizations found in breach of these conditions will not be allowed to participate in next year's chili cook off.

- 20 Tickets per ticket block. Request number of blocks needed with a maximum of 5 blocks. If an organization sells 5 blocks, they may make a special request to sell more.
- All tickets are priced at **\$10.00 each**. Each ticket will receive 10 tasting tickets.
- Please keep track of the number of tickets each individual has from your organization. This will be very important for when you are responsible for returning unsold tickets by the **March 4th, 2022** deadline.

TWO FIRM STIPULATIONS:

1. The Swamp Fox Chili Cook Off organizers **REQUIRE** a minimum of 2 volunteers to help with the event, either on a committee, or as a helper at the event, for a minimum of 1 hour. Event hours for volunteers will begin at 9:00 am and end around 5:00 pm. We will have a Volunteer Coordinator that volunteers will report to.
